## MEMBERSHIP CLASSIFICATIONS

**All memberships include complimentary e-Rangeland News communications and online access to the Rangelands publication.**

**Regular** – Individual membership includes *Rangeland News*, voting privileges, committee service, and nomination & election to any office.

**Additional Regular Family** – Individuals of **same household** desiring more than one Regular membership. MUST PROVIDE NAME AND CONTACT INFORMATION BEFORE THIS CATEGORY IS ACTIVATED.

**Student** – Full-time students (high school through graduate school). Not eligible to hold office. Must succeed to different class of membership in the calendar year following termination of course of study.

**Young Professional** – An early career individual is eligible as a Young Professional member for up to five years and shall enjoy the rights and privileges set forth in paragraph (a) of this section. Young Professional members must succeed to a different class of Membership in the sixth calendar year following their acceptance as a Young Professional.

**Emeritus** – A member is eligible for Emeritus membership in the year he/she becomes 55 years of age, or any year thereafter, provided he/she has retired and has maintained prior membership in the Society for at least 15 continuous years. Membership includes *Rangeland News* (online only) and *Rangelands* (online only), voting privileges, committee service, and nomination & election to any office. \*CHOICE OF PRINT JOURNAL

**International** – Member must reside in one of the countries listed on page 3. Receives online access to both *Rangeland Ecology & Management* and *Rangelands*. \*ONLINE JOURNALS ONLY.

**Life** – All the Regular member benefit; a one-time dues payment. Also includes to online access to REM.

**Additional Life Family** – **Spouse** of life member desiring more than one Life membership.

**Commercial** – Businesses, proprietorships, individuals or other **entities organized for profit**. Must designate a representative. Listed in Society publications.

**Institutional** – Institutions or other entities **not organized for profit** (i.e. Federal agencies, livestock organizations, Registered Native American or First Nations Groups). Membership is in institution's name with a designated representative. Not eligible to hold office. Listed in Society publications.
